### NSCA Coaching Awards Policy and Procedure (current rev. July 2022)

1. High School Strength and Conditioning Coach of the Year Award

## Objectives:

- Improve Awareness and Engagement within HS Coaching Community
- Better align award requirements with HS Coach duties and responsibilities
- Increase nomination activity

Revise points structure and to funnel top three point receiving candidates for vote by the Coaching (RSCC) Taskforce and HS Personal Development Group (PDG) Leadership, overseen annually by the Coaching Program Manager.

#### **Procedure:**

- 1. The NSCA will market and solicit nominees from NSCA membership.
- 2. Additional award nominees may be recommended by the NSCA Coaching Program Manager based on recommendations by SPD, PDG, SIG, and other NSCA Volunteer Program Leaders.
- 3. Nominees must meet the General Award Criteria requirements.
- 4. Nominees must meet the Eligibility Requirements stated in the Criteria Sheet of the award to be considered.
- 5. The nominee shall provide the completed criteria sheet, cover letter, resume or CV, and supporting documentation of involvement, activities and awards to the NSCA National Headquarters by the requested deadline.

#### **Selection Process**

- 1. The process for selection shall be as follows:
  - a) Nominations must be received before the established deadline.
  - b) NSCA Headquarters will verify eligibility requirements and overall points for nominees have been met.
  - c) Qualified nominees will be notified.
    - a. If there are no qualifying nominees, the award will not be given.
  - d) Top three nominees based on points for each award will be sent to the Coaching (RSCC) Task Force and HS PDG Executive Council.
  - e) The Coaching (RSCC) Task Force and HS PDG Executive Council will vote for the winner.
  - f) The Coaching (RSCC) Task Force and HS PDG Executive Council:
    - a. The Coaching (RSCC) Task Force will be volunteers selected yearly by the Coaching Program Manager. The Task Force should include membership from diverse professional and demographic backgrounds.
    - b. It will be apparent that the Task Force is impartial to the nominees.
    - c. If a member of the committee is a colleague, graduate or postdoc advisor or advisee, family member, or close collaborator of a nominee, then the member shall disclose this conflict to the remainder of the committee and recuse himself or herself from service on the subcommittee of the award for which the individual is nominated and from voting for the finalists of that award should the individual be included, if applicable. Committee members may nominate applicants, but may not write supporting letters for nominees during their terms of service.
    - d. The Coaching (RSCC) Task Force will be comprised of >50% non-coaching award recipients and <50% past coaching award recipients.
    - e. The Coaching (RSCC) Task Force will not notify the selected recipients.
    - f. The Coaching Program Manager will notify the Awards and Honors Committee Chair of the winners.

- 2. The Awards and Honors Committee Chair will:
  - a. Notify the Board of Directors of the recipient.
- 3. The NSCA Headquarters will:
  - a. Submit the recipient's name to the Awards and Honors Committee for approval.
  - b. The approved recipient will be sent to the Board of Directors
  - c. Notify the recipients of the award.
  - d. Send regret notifications.
  - e. Create a Press Release announcement of the winners.
  - f. Will verify attendance at the Coaches Conference Opening Ceremony or the National Conference Awards Banquet.
