## ACCREDITATION REVIEW COMMITTEE (ARC) RECOMMENDATIONS FOR ACCREDITATION ACTIONS

A brief ARC update was provided regarding processes and improvements to support programs and accommodate the review of 23 programs in the 2023 cycle.

The board considered recommendations from the Accreditation Review Committee and rendered decisions for all programs in the 2023 cycle.

Programs not meeting accreditation standards and thus resulting in a denial decision, deferred action or granted additional time for further review due to extenuating circumstances will be notified directly.

## STANDARDS COMMITTEE DISCUSSION

Board Liaison Marissa Wehr provided proposed standards revision to recognize the United Kingdom Strength and Conditioning Association (UKSCA) credential as equivalent to the CSCS for faculty/staff qualifications. The discussion explored whether recognition of the UKSCA credential met the intent of the applicable CASCE standards concerning faculty and staff qualifications, and whether this position should be adopted for the current case under review and/or for future consideration.
